COVID-19 over-the-counter, at-home tests

Beginning Saturday, January 15, 2022, employees and their dependents enrolled in a Capital Blue Cross or Geisinger medical plan through the Central Susquehanna Trust will be allowed to purchase up to eight over-the-counter, at-home tests per person every 30 days. This program will be effective for the length of the public health emergency.



For Capital Blue Cross subscribers:

Express Scripts has developed a program that will allow members to go to a participating pharmacy, pick-up an at-home test(s), take it to the pharmacy counter, present their Express Scripts ID card, and receive the test(s) at no cost. The claim cost is limited to \$12 per test and eight tests per person every 30 days.



For Geisinger subscribers:

Geisinger Health Plan will cover over-the-counter, at-home COVID-19 tests without health care provider order or individualized clinical assessment. Members can purchase tests at any network pharmacy and members should present their identification card at the counter. Members will also be able to order tests online from Geisinger's Mail Order Pharmacy.

Tests are for personal, at-home use only and not for employment related purposes.

All US Residents regardless of insurance coverage can now order COVID-19 tests directly from the Federal Government at <https://www.covidtests.gov/>. Each person can get up to four (4) free kits per household and shipping is free.
