# **Medicare Part D**

Trust staff will again be completing the Medicare Part D disclosure filing to CMS on behalf of all CS Trust members with health insurance through the Trust before the August 29<sup>th</sup> deadline.

Also, employers will need to distribute the Medicare Part D notice to all participants covered under the Trust-sponsored health plans by October 14. The notice and more details regarding the distribution will be sent to the employers by the end of September.
