New identification cards for Capital Blue Cross (CBC) members

All CBC members, including dependents, will receive new identification (ID) cards as a result of the Consolidated Appropriations Act (CAA). The CAA requires health plan ID cards to include the member deductible and out-of-pocket maximums that are applicable to the plan. Members should receive the cards by July 1st. Please note that the ID numbers are not changing.

As a reminder, Geisinger members have already received their new cards.

Reminder - Live Healthy School Grant deadline is May 31, 2022

Capital Blue Cross is awarding qualifying school districts in their coverage area a grant of up to \$2,500 to implement a school-based health and wellness initiative. Programs must help students stay physically active, improve nutrition, provide nutrition education, or if related to COVID-19, provide support for student nutrition, student or family meal programs, or study at-home initiatives, etc. Grants will be rewarded based on the program's effectiveness and the number of students impacted.

Recipients will be chosen in June and grants awarded in September 2022. Only one grant will be awarded per school district.

Express Scripts (ES) has notified Central Susquehanna Trust that there were four individuals across the twenty participating CS Trust employers that have been affected by an Express Scripts mobile cybersecurity incident. ES stated that while the investigation is ongoing, the impacted application has been secured and returned to normal business procedures. Express Scripts will notify impacted individuals, provide credit monitoring and a customer support number for member questions. ES takes its members privacy very seriously and protecting its members' information is a critical responsibility for them. They are taking steps to ensure this incident is resolved and that member information is protected from future issues.
