CBC Wellness Webinars

As part of the Capital Blue Cross Agreement, all participating employers must complete one virtual or onsite wellness planning session annually with Capital Blue Cross.

To assist in meeting the 2022/2023 requirement, five different sessions have been scheduled between November 15, 2022 and March 7, 2023. By joining one of these sessions, the employer will satisfy the 2022/2023 requirement.

Medicare Part D Notice – Distribution Required by October 14, 2022

The Medicare Part D notice needs to be distributed to participants (including COBRA and Retirees) covered under the Trust-sponsored CBC and Geisinger health plans by October 14, 2022. The notice and cover letter were emailed to the business managers with medical insurance through CS Trust on September 19.

Express Scripts

Pharmacists have been granted new prescribing authority from the FDA, allowing them to prescribe PAXLOVID™ to eligible patients testing positive for COVID-19.

Savings are expected to be substantial for both patients and plans when Paxlovid is prescribed and dispensed by a pharmacist versus a physician.

Express Scripts is offering a new program for persons enrolled in a Capital Blue Cross medical plan. The program has been reviewed and recommended by Solicitor Balducci and also approved by the CS Trust Officers. The item will be included on the next CS Trust agenda for ratification by trustees.
